





The CEO will be expected to set and deliver an ambitious agenda that reflects the aspirations of a sector with extraordinary potential. The role will ensure that the BIA is not only the voice of UK life sciences but also a driving force in creating the policy, regulatory, and investment environment in which members can thrive and scale globally.

Key Responsibilities

- Strategic Leadership: Lead the Association and Senior Leadership Team in developing and delivering a clear, ambitious strategy and long-term vision. Act as principal policy advisor to the Board, ensuring the organisation's direction reflects both member needs and sector opportunities.
- Member-Driven Growth Agenda: Engage deeply with the membership to understand their growth ambitions

- Representation & Advocacy: Serve as the BIA's principal spokesperson, building and maintaining strong relationships with Government Ministers, MPs, regulators, media, and industry leaders. Represent the Association at conferences, in the media, and in strategic forums to promote sector growth and influence policy outcomes.
- Policy Development: Maintain oversight of political, economic, legislative, and regulatory trends affecting the
 industry. Direct policy development and secure Board approval for priorities that deliver real-world benefits to
 members and the wider sector.
- **Governance & Compliance:** As a Board Director, uphold fiduciary duties, ensure compliance with the Articles of Association and relevant laws, and maintain the trust of the Board and members.
