**Global Fund to Fight AIDS, Tuberculosis and Malaria**  
Executive Director

## Our Client

The Global Fund intends to appoint a new Executive Director for a four-year term from 2027, which the Board may renew once.

The next Executive Director will be an exceptional leader, driving implementation of the Global Fund strategy, delivering results, and engaging effectively with external stakeholders and partners. A gifted leader of people and systems, the Executive Director will bring proven experience in leading large, complex organizations, mobilizing resources in an evolving donor landscape, driving and guiding change, and nurturing partnerships. Alongside strategic, diplomatic and adaptive leadership expertise, they will bring broad international and cross-sectoral experience, financial acumen and external credibility. The next Executive Director will impart a compelling vision for the realization of the organization's mission, navigate a quickly evolving global health ecosystem and funding landscape, and serve as a leader in the ongoing work to strengthen collaboration with other global health institutions. They will be firmly committed to the partnership model, the principles of the Global Fund and the people it serves.

## The Global Fund

### Background

Created in 2002, the Global Fund to Fight AIDS, Tuberculosis and Malaria is a worldwide partnership dedicated to ending the three epidemics and building stronger, more equitable health systems. Each year, the Global Fund invests up to US\$5 billion to combat infectious diseases and strengthen health and community systems in more than 100 countries.

The partnership unites governments, civil society, communities affected by the diseases, health workers, technical and multilateral agencies, and the private sector to identify and scale what works – so that the world achieves faster, more sustainable progress.

The Global Fund invests in the fight against HIV, tuberculosis and malaria through a partnership-based funding model, raising funds in three-year replenishment cycles. Financing comes primarily from donor governments, as well as from the private sector, philanthropy and innovative financing instruments.

Since its inception, the Global Fund partnership has saved 70 million lives and contributed to steep declines in deaths and new infections of the three diseases. These gains have benefits beyond health. For example, in 15 sub-Saharan African countries, life expectancy rose from 49 years to 61 years, with more than half of that gain attributed to progress against AIDS, TB and malaria. In 2024, programs supported by the Global Fund provided antiretroviral therapy to 25.6 million people living with HIV, treated 7.35 million people for tuberculosis and distributed 162 million insecticide-treated mosquito nets to prevent malaria. During the same period, nearly US\$2.7 billion was invested in strengthening health and community systems – a cornerstone of the Global Fund's approach to achieving universal health coverage and pandemic preparedness.

Led by Executive Director Peter Sands, the Global Fund continues to implement the ["Global Fund Strategy \(2023–2028\): Fighting Pandemics and Building a Healthier and More Equitable World."](#) The strategy reaffirms the Global Fund's unique role as a high-impact, performance-based partnership combining country ownership, innovation and accountability to deliver results and strengthen global health security.

The search for the next Global Fund Executive Director comes at a pivotal moment for global health. Global trends – rising pressures on official development assistance, shifting geopolitical priorities, and tighter fiscal space in many donor and implementing countries – are reshaping the environment in which health programs operate. These changes are placing new strains on the systems that deliver lifesaving services. As the Global Fund partnership works to sustain and expand its impact, its focus remains on supporting countries to navigate this evolving landscape and ensuring that resources are translated rapidly and efficiently into high-quality programs that save lives.

Under the Board's guidance and oversight and through the leadership of the Executive Director, the Global Fund will remain a partner to countries and communities in accelerating the pathway to self-reliance by strengthening efficiency, adopting cutting-edge tools and approaches, and building a simpler, more coherent and more country-responsive global health ecosystem.

## The Role

### Introduction

- i. The Executive Director is the Chief Executive Officer of the Global Fund and is responsible for the overall leadership and management of the Global Fund's operational and administrative functions. Working under the guidance of the Global Fund Board, the Executive Director defines the organization's strategic vision and is accountable for its implementation and the results achieved.
- ii. The Executive Director maintains strong relationships with a diverse range of stakeholders that are important collaborators in the Global Fund's mission and activities.
- iii. The Executive Director has the responsibility and accountability to set the tone for the Global Fund Secretariat's internal and external interactions by exemplifying values of high ethical standards, integrity and fairness. The incumbent must act in the best interests of the Global Fund in all contexts, and is responsible for ensuring this culture prevails across the organization's employees and contractors.

### Duties and Responsibilities

- i. The Executive Director reports directly to the Global Fund Board. As head of the Secretariat, the Executive Director works closely with the leadership of the Global Fund Board and its Standing Committees, the Ethics Officer and the Office of the Inspector General, and the members of the Management Executive Committee.
- ii. Given the importance of maintaining the management continuity process of the organization, the Executive Director is expected to appoint a Deputy Executive Director to ensure that managerial responsibilities may be efficiently carried out without interruption throughout the year, in particular during absences for business-related travels.
- iii. The Executive Director's primary responsibilities are as set out below.

### Managing Finance, People and Systems

The Executive Director will:

- i. **Operational Management**
  1. Ensure that the Global Fund's organizational structure, operational policies and other business processes are sound and able effectively to deliver on the strategic objectives of the strategy defined by the Global Fund Board;
  2. Exercise authority over personnel and human resource matters and further strengthen performance management by tracking key performance indicators across the organization;

3. Maintain a positive work environment that facilitates collaboration and information sharing and is conducive to attracting, retaining and motivating diverse talent;
4. Lead the Secretariat's internal management committees as the mechanism for ensuring aligned internal leadership and implementation; and
5. Effectively manage operational or financial matters to deliver on the mandate of the Global Fund, including by seeking additional authority from the Board as may be needed to address risks that arise proactively and effectively.

ii. **Financial Management**

1. Present annual financial budgets for Board approval that link to the corporate workplan, and more routinely throughout the fiscal year, multi-year resource projections for the transparent management of resources;
2. Work closely with the Chief Financial Officer to ensure the overall transparent and effective financial and administrative functionality of the Global Fund and its assets; and
3. Oversee the management and implementation of all organizational contracts according to corporate procurement systems and practices that deliver value for money and focus on the primary work of the Global Fund.

iii. **Official Representation**

1. Represent the Global Fund before any competent authority (in particular any Federal or Cantonal authority of Switzerland) when delegated by the Chair and Vice-Chair of the Board.

## Strategic Leadership and Delivery

The Executive Director will:

- i. Operationalize, lead and monitor the implementation of the Global Fund's Strategy, and ensure the effective implementation of new business models and instruments to deliver on the strategic objectives;
- ii. Represent the Global Fund Secretariat at the highest level, ensuring its role within the global health architecture is well understood, through direct engagement with policy-makers and the execution of an effective media strategy;
- iii. In close collaboration with the Office of the Inspector General and the Audit and Finance Committee of the Board, ensure that there are strong fiduciary controls in place to monitor the use of Global Fund resources;
- iv. Effectively manage risk in the portfolio and the Secretariat's operations, including, but not limited to, the development of rigorous management and communications systems to ensure the implementation of and strict adherence to Board decisions and other Global Fund policies in a timely manner; and
- v. Ensure meaningful monitoring and evaluation of Global Fund programs and performance and the provision of accurate analysis and routine reporting on the impact and performance of the Global Fund's grant portfolio.

## Partner Engagement, Working with the Board, and Mobilizing Resources

The Executive Director is responsible for building and maintaining effective alliances as part of a coordinated response to the three diseases at the country and international levels. This includes effective interactions with and responsiveness to the full range of public and private partners that are key stakeholders in building and sustaining appropriate national-level responses.

- i. **Partner engagement.** To safeguard and continually strengthen the effectiveness, reputation and profile of the Global Fund, the Executive Director will work closely with the Board and its committees to:

1. Build and maintain effective alliances and operational collaboration with public and private partners, such as governments of implementing countries, United Nations agencies, bilateral donors, non-governmental organizations, the business sector, civil society actors, and communities affected by the three diseases;
  2. Represent the Global Fund and its work with external stakeholders to build effective partnerships with public and private entities to support the work of the Global Fund;
  3. Strengthen access by implementing countries and affected populations to cost-effective, innovative products and services that increase the availability of high-quality, sustainable services that are most relevant to the specific epidemiological context in which implementation is occurring;
  4. Interact with governments at the highest political level to advocate for an appropriate level of national resources to be directed to at-risk populations; and
  5. Maintain effective communications with all stakeholders.
- ii. **Mobilizing and sustaining resources.** To support the Board in its core function of mobilizing public and private sector donors to support the mission of the Global Fund, the Executive Director will:
1. Provide strategic guidance for resource mobilization and the implementation of the Global Fund's replenishment mechanism;
  2. Oversee and advance the development of new funding streams for the Global Fund, broadening the donor base and encouraging increased investment in programs from implementing countries themselves;
  3. Ensure the highest level of confidence among public and private donors in the Global Fund operations and impact to support longer term predictable financing being contributed to the Global Fund as the multilateral financing mechanism of choice for the three diseases; and
  4. Engage with other regional groups of implementing and non-implementing countries, communicating the Global Fund's purpose and aiming to secure their support.
- iii. **Working with the Board.** To support the Board in its strategic leadership of the organization, the Executive Director will:
1. Report to the Board on the operational, administrative and financial aspects of the Global Fund at each Board meeting;
  2. Ensure that the Board is made aware, in a timely way, of key strategic and other material operational challenges the Secretariat is encountering in the course of its work;
  3. Represent the management of the Secretariat at Board Meetings, and ensure effective and timely preparation and distribution of all materials in accordance with Board-mandated policies and procedures;
  4. Participate (or nominate a delegate to participate) at all non-Executive sessions of Committee meetings, and assist the Committees of the Board, their advisory and technical panels and other support structures;
  5. Communicate Board decisions to the Global Fund's staff and other relevant stakeholders; and
  6. Assist the Board Chair and Vice-Chair in evolving and strengthening the overall governance of the Global Fund.

## Candidate Profile

### Knowledge and Experience

Candidates for the role of Executive Director will be able to prove their:

- i. Track record as senior leaders of complex and internationally diverse organizations;
- ii. Track record in building and strengthening a strong aspirational organizational culture based on the Global Fund values;
- iii. Success as builders of mutually supportive multicultural teams;
- iv. Leadership of organizations operating in changing global contexts;
- v. Exposure to a range of partnership models in both financing and delivery of programs;
- vi. Sensitivity to issues relating to HR management, diversity, gender equity, and human rights internally and externally; and
- vii. Fluency in English and experience of working in a multilingual environment.

It will be desirable for candidates to bring:

- i. Credentials in the creation and cultivation of successful partnerships with governments, civil society actors and the private sector;
- ii. Substantive knowledge and experience in one or several of the following areas: international development, international health financing and development financing, public health and/or in responding to the three diseases and/or health systems;
- iii. Experience of working effectively in and/or with implementing countries; and
- iv. Fluency in another language or languages.

### Competencies

The core competencies required for the role are:

- i. **Operational Management Skills**
  1. Exceptional management skills of people, finances and systems, with a proven capacity to motivate and lead a multidisciplinary management team to achieve organizational goals according to a risk-aware implementation framework;
  2. Team-building ability, the capacity to instill a culture that values measurable achievement, mutual support and compliance with organizational processes;
  3. A focus on sustainable results that deliver improved health outcomes for affected populations;
  4. A grasp of detail and an understanding of global health and/or development financing through grant and/or loan-making and grant/loan-management, or comparable financing mechanisms, balanced by well developed delegation and senior team management skills;
  5. An ability to make difficult decisions when required on organizational development, balanced by experience in constructive engagement with staff on change management processes and their value to the organization as a whole; and
  6. A facilitative approach that enables effective delivery with and through partner organizations.

ii. **Strategic Capability**

1. A strong analytical mind and the ability to grasp the nature and direction of the Global Fund strategy and help shape it in the future;
2. The capacity to work collaboratively with a large and complex Board in the development and articulation of its vision and on its translation into tangible results and longer term impact;
3. An appreciation of the issues facing partners in implementing countries and opportunities that exist to alleviate barriers to successful implementation of national programs; and
4. A clear focus on organizational goals amid multiple competing risks and demands, and a capacity to prioritize effectively in order to deliver results.

iii. **Advocacy and Representation Skills**

1. Strong public-speaking and influencing skills;
2. Presence, gravitas, humility and empathy in dealings with partners from a variety of backgrounds;
3. An ability to engage and operate effectively at the highest political levels; and
4. Understanding of and an ability to strategically lead on resource mobilization activities.

iv. **Personal Attributes**

1. Strong inter-personal skills;
2. Role model of ethical standards and integrity;
3. Familiarity and ease with a variety of cultures and comfort with diverse groups;
4. Strength of personality and robustness of intellect;
5. Sound judgment combined with humility and a focus on personal development and continued learning; and
6. The ability to work with a multi-constituency board as a credible partner: informing its decisions and deriving the maximum advantage for the Global Fund from its collective experience.

## Location

The Executive Director will be based at the Global Fund's Secretariat in Geneva and will travel extensively. The working language of the Global Fund is English, with many other languages spoken.

## Term of Appointment and Performance Expectations

The performance-based approach the Global Fund adopts to its programs, applies also to its leadership. The anticipated initial term of appointment for the Executive Director is for four years. Employment is strictly subject to performance against an agreed set of criteria through an annual review process.
